If trial does not fill, day of trial entries will be accepted

Entries will be accepted as received. Your entry must be complete with BHA number and signed liability waiver. We reserve the right to limit entries to fall within the time constraints of a judging day, a maximum of 120 runs per day.

Classes offered Saturday and Sunday: Instinct, Novice, Open, Senior, Master. Move ups will be allowed between trials. Facility will open at 8:00 am all days. Day of Trial entries will close at 8:30 am each day. Judges briefing will be at 8:45 am and first dog on the line for first trial, both days, at 9:00 am. Classes will run in the following order on both days: Trial One: Instinct / Novice / Open / Senior / Master. Trial Two: Master / Senior / Open / Instinct / Novice. Saturday will be run Small to Tall for both trials. Sunday will be run Tall to Small for both trials.

Awards: Ribbons will be awarded for all Qualifiers in the Regular classes and the Instinct Test.

Placement ribbons will be awarded for First, Second, Third and Fourth place. Rosettes will be awarded for new titles. High In Class will be awarded for Novice, Open, Senior, and Master in each trial.

Exhibitor Information

1. Barn Hunt information, dog registration, rules and more can be found at www.barnhunt.com
2. The trial will be held indoors on concrete. Bring what you need to keep yourself and dogs comfortable, ie chair, crate, shade, water, etc. Indoor bathrooms will be available.
3. Dog's minimum age to compete in the Barn Hunt Trial is 6 months of age.
4. All dogs must be under control and on a short leash while on trial grounds except while showing. **Flexi leashes and electric collars are not permitted** at the show site.
5. There is no smoking in this facility or on the grounds. If you must smoke you will need to do so inside your vehicle and dispose of the butts in the vehicle also.
6. Please pick up after your dog and dispose of waste in appropriate containers outside the building.
7. **Bitches in season** may compete at Barn Hunt trials. They will be run at the end of each class. Bitches in season must wear pants. If bringing a bitch in season, please inform the trial committee prior to the trial and inform all exhibitors at the judge's briefing.
8. Refunds offered only for injured dogs with veterinary note. Requests for refunds must be made before or on the closing date. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee.
9. Every attempt will be made to hold this event as scheduled. In the event of an "act of God" such as flood or fire, or civil disturbances or any other causes beyond the control of the organizing committee, an event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. We will return all or part of the entry fees at our discretion.
10. **Disruptive dogs** will have to be crated outside the building. If your dog cannot handle other dogs or people walking past their crate, plan to crate outside the trial area. Please bring adequate shade.
11. Please make sure your crate is secure as the dogs may be highly excited. If your dog is overly excited do not leave him/her unattended.
12. **Lunch will not be provided.** There are fast food restaurants and a grocery store approximately ten minutes away.
13. Bottled water and trail mix will be available for volunteers.
14. **Directions to the trial site: Please Enter at the DMV Road, not by the big Legacy Events Center building.**
From the North: Take I-15 toward Salt Lake City. Take EXIT 325 toward Lagoon/Park Dr/Farmington. Turn RIGHT onto PARK LN. **
From the South: Take I-15 North from Salt Lake City. Take the US89 N exit, EXIT 324 toward I84 E/So Ogden. Take EXIT 395 toward Farmington. Turn LEFT onto PARK LN.... *
** * ... then turn LEFT onto 1100 West. Take the THIRD exit from the Roundabout (this will be Clark Lane). Turn RIGHT after the DMV (this road is between the DMV and the Adult Probation and Parole Center). Follow this road around to the right to the parking lot. Building #3 is the closest silver building to the parking lot.
