No refunds of entry fees will be issued after the closing date.

Entries will be accepted as received. Your entry must be complete with BHA number and signed liability waiver. We reserve the right to limit entries to fall within the time constraints of a judging day, a maximum of 120 runs per day.

Classes offered each day: Instinct Test (1 on Saturday and 1 on Sunday), Novice, Open, Senior, Master. Trial 2 will follow Trial 1. **(PLEASE NOTE THE CLASS RUN ORDER IS DIFFERENT FROM OUR PAST TRIALS!)** The class run order for both days will be as follows: Trial 1: Instinct / Novice / Open / Senior / Master; Trial 2: Novice / Open / Senior / Master. Move ups will be allowed between trials. Facility will open at 7:30 am all days. Day of Trial entries will close at 8:00 am for Trial 1, 11:30 am for Trial 2. Briefing will be at 8:15 am and first dog on the line for the first class at 8:30 am. Trial 2 will begin at 12:30 pm, or one half hour after the end of Trial 1, whichever is latest. Saturday Trials will be run Tall to Small. Sunday Trials will be run Small to Tall. (Also note that height order is flexible as many handlers run multiple dogs.)

Entry fees are \$10 for Instinct, \$15 for Novice/Open/Senior/Masters. Day of Show fees are the same as pre-entry. **Barn Hunt registration numbers are required for valid entry.** (Registration numbers can be obtained on the website: www.barnhunt.com.)

Awards: Ribbons will be awarded for all Qualifiers in the Regular classes and the Instinct Test.

Placement ribbons will be awarded for First, Second, Third and Fourth place. Rosettes will be awarded for new titles. High In Class will be awarded for Novice, Open, Senior, and Master in each trial.

Exhibitor Information

1. Barn Hunt information, dog registration, rules and more can be found at www.barnhunt.com
2. Dog's minimum age to compete in the Barn Hunt Trial is 6 months of age.
3. All dogs must be under control and on a short leash while on trial grounds except while showing. **Flexi leashes and electric collars are not permitted** at the show site.
4. There is no smoking in this facility or on the grounds. If you must smoke you will need to do so inside your vehicle and dispose of the butts in the vehicle also.
5. Please pick up after your dog and dispose of waste in appropriate containers outside the building.
6. **Bitches in season** may compete at Barn Hunt trials. They will be run at the end of each class. Bitches in season must wear pants. If bringing a bitch in season, please inform the trial committee prior to the trial and inform all exhibitors at the judge's briefing.
7. Refunds offered only for injured dogs with veterinary note. Requests for refunds must be made by the closing date. Entry fees will not be refunded after the closing date in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee.
8. Every attempt will be made to hold this event as scheduled. In the event of an "act of God" such as flood or fire, or civil disturbances or any other causes beyond the control of the organizing committee, an event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. We will return all or part of the entry fees at our discretion.
9. **Disruptive dogs** will have to be crated outside of the trial area. If your dog cannot handle other dogs or people walking past their crate, plan to crate outside the trial area.
10. Please make sure your crate is secure as the dogs may be highly excited. If your dog is overly excited do not leave him/her unattended.
11. **Lunch will not be provided.** There are fast food restaurants and a grocery store approximately ten minutes away.
12. Bottled water and trail mix will be available for volunteers.
13. **Directions to the trial site:**
From the North: Take I-15 toward Salt Lake City. Take EXIT 325 toward Lagoon/Park Dr/Farmington. Turn RIGHT onto PARK LN. Continue to follow PARK LN which becomes 1100 W. End at 151 S 1100 W. You'll see the big blue building on your left. From the South: Take I-15 North from Salt Lake City. Take the US-89 N exit, EXIT 324 toward I-84 E/So Ogden. Take EXIT 395 toward Farmington. Turn LEFT onto PARK LN. Continue to follow PARK LN which becomes 1100 W. End at 151 S 1100 W. You'll see the big blue building on your left.
