No refunds of entry fees will be issued after the closing date.

Classes offered each day: Instinct, Novice, Open, Senior, Master  
Instinct Test offered in T1, T3 and T5 only

Crazy 8 offered in T1 and T3 only – class limited to 10 entries each, additional entries will be waitlisted  
Trials will run consecutively each day, i.e Trial 2 will follow Trial1, etc.

We will have a one judge/two ring trial. Class order is as follows:

Friday Trial 1: Instinct / Senior / Novice / Master / Open/ Crazy 8; Friday Trial 2: Novice / Senior / Open / Master.  
Saturday Trial 3: Open / Master / Instinct / Senior / Novice/ Crazy 8; Saturday Trial 4: Open / Master / Novice / Senior.  
Sunday Trial 5: Instinct / Master / Novice / Senior / Open; Sunday Trial 6: Novice / Master / Open / Senior.

Move ups will be allowed between trials. Facility will open at 8:00 am all days. Briefing will be at 8:45 am and first blind will start to run at 9 am.

Trial 2 will begin at 12:30 pm, or one-half hour after the end of Trial 1, whichever is latest.

Friday/Sunday Trials will run Small to Tall. Saturday Trials will run Tall to Small. (Note that height order is flexible as many handlers run multiple dogs.)

Entry fees are \$10 for Instinct; \$15 for Novice/Open; \$20 for Senior/Masters/Crazy 8's. Day of Show Entries, and entries received after the closing date, will be \$3.00 more per run.

Entries will be accepted as received. Your entry must be complete with BHA number and signed liability waiver. We reserve the right to limit entries to fall within the time constraints of judging, a maximum of 120 runs/8 hrs per day.

**Awards:** Ribbons will be awarded for all Qualifiers in the Regular classes and the Instinct Test. Placement ribbons will be awarded for First, Second, Third and Fourth place. Rosettes will be awarded for new titles. High In Class will be awarded for Novice, Open, Senior, and Master in each trial.

#### Exhibitor Information

1. Barn Hunt information, dog registration, rules and more can be found at [www.barnhunt.com](http://www.barnhunt.com)
2. Dog's minimum age to compete in the Barn Hunt Trial is 6 months of age.
3. All dogs must be under control and on a short leash while on trial grounds except while showing. **Flexi leashes and electric collars are not permitted** at the show site.
4. There is no smoking in this facility or on the grounds. If you must smoke you will need to do so inside your vehicle and dispose of the butts in the vehicle also.
5. Please pick up after your dog and dispose of waste in appropriate containers outside the building.
6. **Bitches in season** may compete at Barn Hunt trials. They will be run at the end of each class. Bitches in season must wear pants. If bringing a bitch in season, please inform the trial committee prior to the trial and inform all exhibitors at the judge's briefing.
7. Refunds offered only for injured dogs with veterinary note. Requests for refunds must be made by the closing date. Entry fees will not be refunded after the closing date in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee.
8. Every attempt will be made to hold this event as scheduled. In the event of an "act of God" such as flood or fire, or civil disturbances or any other causes beyond the control of the organizing committee, an event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. We will return all or part of the entry fees at our discretion.
9. **Disruptive dogs** will have to be crated outside of the trial area. If your dog cannot handle other dogs or people walking past their crate, plan to crate outside the trial area.
10. Please make sure your crate is secure as the dogs may be highly excited. If your dog is overly excited do not leave him/her unattended.
11. **Lunch will NOT be provided.** Snacks and water will be available but please be sure to bring food and water for yourself and your dogs.
12. **Directions to the trial site:** From Salt Lake City: Take I-80 West past airport. Take exit 99 to Tooele. Now traveling on SR 36. Continue past Lake Point. Before Stansbury Park, turn right at street light SR 138. Proceed to Sheep lane and turn left. The Complex is at the corner of Sheep lane and SR 112 and must be entered from SR 112.
13. Please note that this is a Public use area and there will be other non-dog related activities going on. Please make sure to watch your dogs closely and follow all BarnHunt rules.
14. Do not allow your dogs to potty on any buildings or fencing.
15. BHA rules & common courtesy: you are responsible for picking up after your dogs at the motels and show site.
