### 2 Clinics

Taught by Barn Hunt judge Jalynn Davis.

Clinic 1: Intro to Barn Hunt, 8-9 am. This 1 hour session will introduce participants to the sport of Barn Hunt. It will cover the background of Barn Hunt, basic rules and how to participate in a trial. Dogs will be introduced to a rat and taught the basics of tunnels and climbs. Cost is \$35 and includes a current book of rules and 1 entry in the fun test. Handler can choose level.

Clinic 2: Intermediate/Advanced. 9-11:30 am. This session will cover search patterns, increasing drive, developing indications, handling strategies and tunneling issues. Cost is \$30 and includes 1 entry in the fun test. Handler can choose level.

11:30 – 1:00 pm. We will be holding a club meeting and the BBQ/potluck between the clinics and trial.

#### Exhibitor Information

1. Barn Hunt information, dog registration, rules and more can be found at [www.BarnHunt.com](http://www.BarnHunt.com)
2. Dog's minimum age to compete in the Barn Hunt Trial is 6 months of age.
3. All dogs must be under control and on a short leash while on trial grounds except while showing. **Flexi leashes and electric collars are not permitted** at the show site.
4. There is no smoking in this facility or on the grounds. If you must smoke you will need to do so inside your vehicle and dispose of the butts in the vehicle also.
5. Please pick up after your dog and dispose of waste in appropriate containers outside the building.
6. **Bitches in season** may compete at Barn Hunt tests. They will be run at the end of each class. Bitches in season must wear pants. If bringing a bitch in season, please inform the trial committee prior to the trial and inform all exhibitors at the judge's briefing.
7. Refunds offered only for injured dogs with veterinary note. Requests for refunds must be made by the closing date. Entry fees will not be refunded after the closing date in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee.
8. Every attempt will be made to hold this event as scheduled. In the event of an "act of God" such as flood or fire, or civil

disturbances or any other causes beyond the control of the organizing committee, an event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. We will return all or part of the entry fees at our discretion.

**9. Disruptive dogs** will have to be crated outside of the trial area. If your dog cannot handle other dogs or people walking past their crate, plan to crate outside the trial area.

**10.** Please make sure your crate is secure as the dogs may be highly excited. If your dog is overly excited do not leave him/her unattended.

**11. Directions to the trial site:** From Salt Lake City: Take I-80 West past airport. Take exit 99 to Tooele. Now traveling on SR 36. Continue past Lake Point. Before Stansbury Park, turn right at street light SR 138. Proceed to Sheep lane and turn left. The Complex is at the corner of Sheep lane and SR 112 and must be entered from SR 112.

## FunTest Rules

please see complete rules at [www.barnhunt.com](http://www.barnhunt.com)

1. Competitors may enter any level they wish at a Fun Test, and may enter more than one level and/or multiple times at the same level if allowed by the Club (i.e., Clubs may allow competitors to enter Novice multiple times with the same dog and/or may allow the competitor to enter the same dog in Novice, Open, Senior, and Master).

2. Clubs may choose to allow training in the ring, and if allowing training, whether or not treats will be allowed in the ring. All regular ring and rat safety and handling rules apply. Training must be completed within the time allowed for the class entered. As soon as the Judge confirms training is occurring, the Judge calls TRAINING to the Scribe, who marks an X on the Scribe sheet. The Judge monitors but does not aid or assist any training activities other than pointing out a rat location on request. Dogs being trained in the ring do not qualify for any offered class awards. If training:

a) Dogs may remain on a collar/harness and leash if no tunneling effort is to be attempted, and/or the handler may openly carry a collar/leash. All dogs wearing a collar/harness must also be restrained by a leash to prevent an attempt at a tunnel. A collar/leash may never be used punitively in the ring or to pull a dog through a tunnel or up onto a bale. A collar/leash may be used to steady a dog and prevent the rat tube from being roughed. No dangling tags or other dangling items are allowed.

b) Handlers may carry and use toys in the ring.

c) All treats, if allowed, must be kept in a pocket or waist pack and cannot be placed on a tube or a bale, but must be directly fed to the dog. Any dropped treats must be completely removed by the competitor.

3. Handlers may train in the ring in other ways, but no punitive/harsh training is allowed and no training which would harm the rat is allowed. Punitive/harsh training is grounds for dismissal from the Fun Test grounds.
